【出願資格変更内容】

2028 年度入学 (2027 年度実施) 推薦入学試験より、関西学院大学が指定する以下のプログラム修了者 (修了見込者) のみを出願資格対象とします。これに伴い、以下に該当しない者は本推薦入学試験の出願資格の対象外となります。

- <①関西学院大学総合政策学部「グローバルキャリアプログラム (GCaP)」修了者 (修了見込者) >
- <②関西学院大学「国連・外交プログラム」修了者 (修了見込者) >

次の(1)～(3)のすべてに該当する者。

- (1)大学卒業者および 2027 年 3 月卒業 (早期卒業を含む) 見込の者。
- (2)総合政策学部「グローバルキャリアプログラム (GCaP)」または関西学院大学「国連・外交プログラム」を修了した者、または修了見込みの者。
- (3)総合政策研究科国連システム政策専攻を専願し、合格した場合は本専攻に入学できる者。

※希望する指導教員に事前に必ず連絡を取り、面談を済ませた上で出願してください。事前相談のないまま出願された場合、受験が認められないことがありますので注意してください。

Notice of Change in Application Eligibility Requirements for the Recommendation-based Admission
Graduate Department of UN System Policy Studies, Kwansai Gakuin University (Master's Course)
For April 2028 Enrollment

Regarding the Graduate School Recommendation- based Admission for April 2028 Enrollment (to be conducted in AY 2027) administered by the Graduate Department of UN System Policy Studies at Kwansai Gakuin University, the following change in application eligibility requirements is scheduled.

Please note that details of the Graduate School Entrance Examination for April 2027 Enrollment (conducted in AY 2026) will be provided in the Admissions Guidelines, which are scheduled to be published in June 2026.

【Change to Application Eligibility Requirements】

Beginning with the Graduate School Recommendation- based Admission for April 2028 Enrollment (conducted in AY 2027), application eligibility will be limited to applicants who meet the criteria listed below.

Applicants who do not fall under the categories will no longer be eligible to apply.

- (i) Those who have completed or are expected to complete the "Global Career Program (GCaP)" at School of Policy Studies, KGU**
- (ii) Those who have completed or are expected to complete the bachelor level "UN and Foreign Affairs Studies Program" at KGU**

Applicants must satisfy **all** of the following conditions (1) through (3):

- (1) Individuals who have graduated from a university or are expected to graduate in March 2027 (including early graduation).
- (2) Individuals who have completed or are expected to complete either the "Global Career Program (GCaP)" in the School of Policy Studies or the "UN and Foreign Affairs Studies Program" at Kwansai Gakuin University.
- (3) Individuals who apply **exclusively** to the Graduate Department of UN System Policy Studies, Graduate School of Policy Studies, and can assure to enroll in the department if accepted.

***Before applying, you must contact a faculty member of the department you wish to be supervised by, complete a consultation with the prospective research supervisor, and obtain approval prior to application submission. Please note you may not be allowed to take the entrance examination if you apply without consultation by prospective research supervisor in advance.**
